

My name is Pastor Ralph Olmos. I'm the CEO growing food pantry in San Jose, Ca called Lighthouse Food Rescue and Distribution, or LFRAD. This entity is the result of many interfaith partnerships in the Silicon Valley including the Buddhist Temple, Catholics such as Martha's Kitchen and Loaves and Fishes. Other developing partnerships include Second Harvest Food Bank, and the City of San Jose. Among these partnerships is the first and most valued, Hunger at Home. I met their CEO, Ewell Sterner, in mid-2020 and discovered just how we think alike and how dedicated we both are to our common mission; "Eliminate all Food Insecurity Within the Silicon Valley". We discussed each other's food sources and distribution models. Then we discussed the possible ways that we could help each other.

Here's a personal example, when Ewell learned that one of our food distribution methods is through our Free Farmers Market, he suggested that they start supplying us with high quality produce as well as other items requiring refrigeration. Hunger at Home still provides most of our produce as well as items requiring refrigeration today.

In summary, it is accurate to say that Lighthouse Food Rescue and Distribution would not be where it is without the continued help from Hunger at Home.

As an individual committed to helping the working poor, the unsheltered, low income seniors and, more recently, newly arrived refugees in the great Bay Area, I have the privilege of collaborating very closely with Hunger At Home to provide much need food and other items to those in need.

A prime example of HAH 's ability to respond quickly and effectively in fulfilling gaps in the food insecurity landscape happened when I received a call from a refugee informing me of over 150 refugees staying at a hotel in San Jose who were in need of fresh produce, snacks, dairy and other products. All it took was a phone call to the management team, who immediately asked for a list of items needed and for me to drive over to pick up. The management and staff filled my SUV to the brim with all the items on the list for distribution at the hotel. All this in less than 60 minutes!

Over a period of more than 2 years, I, along with my group of friends, have provided food, and other needed items, all with the help of HAH, to three senior housing complexes – two in Santa Clara County with over 400 apartments and one in Manteca with 82 families, meals 3 time a week to 150 unsheltered people, and to over 300 refugees on a weekly basis. We could not have done this without the help of HAH.

It has also been my privilege to introduce other nonprofits, who together are serving over 1800 families, to HAH, an organization with an open door, and more importantly, a generous heart to do what needs to be done – which is to ensure anyone suffering with food insecurity knows there is a place that will fulfill their needs. And that organization is HUNGER AT HOME!!

Having worked with many nonprofits, the one that never disappoints is Hunger at Home. I look forward to many years of continued collaboration in helping those in need. A huge thank you to Ewell, Dinari, Michelle, Michael and every staff member, who always greet you with a smile and “How can we help?”

When Wesley United Methodist Church decided in May 2020 to start a weekly Food Distribution for our neighbors in San Jose's Japantown, we were referred to Hunger at Home for help. At first we used our volunteers' SUVs, pickups, and vans to haul the food. We soon upgraded to a rental truck to keep up with the demand. Hunger at Home weekly fixes us up with produce, pre-made meals, and a wide variety of other groceries to pass on to our thankful clients. Through the nearly two years that we have been distributing food, Hunger at Home has been a great partner, enabling us to help meet the food needs of literally thousands. They make our Food Distribution possible, and the people of Wesley Church and San Jose's Japantown are forever grateful.
